The injured labourer was immediately shifted to a hospital but succumbed to his injuries.

The Anjuman Tajran Nasirabad strongly condemned the killing of the labourer and blocked the Quetta-Sukkur National Highway, carrying his body. Traffic remained suspended for at least six hours, causing severe difficulties for passengers and others.

They claimed that the police had failed to address the law and order situation. Last month, a Hindu trader was also killed in the same area over a ransom dispute. Leaders of traders and political parties strongly condemned the worsening situation in the district and demanded that the Nasirabad superintendent of police should be transferred without any delay.

However, the protesters opened the highway after negotiations with Deputy Commissioner Zulfiqar Ali Karar, FC Commandant Col. Rizwan Tayyab, police officials, and other concerned authorities. The authorities assured them that steps would be taken to restore peace and order.
