which the chief minister and other individuals were nominated.

Mr Afridi is also facing a case in the Election Commission of Pakistan for the code of conduct violation during a recent by-election on a national seat in Khyber Pakhtunkhwa. His lawyers have, however, challenged the ECP's jurisdiction in the case while also moving the high court against the election watchdog.

The ECP had summoned the CM after he threatened the election staff during a political gathering in Havelian, Abbottabad, ahead of the by-poll in NA-18.

It may be noted that Mr Afridi has been tasked by party leader Imran Khan, who is in jail, to lead the 'street movement' against the government. He visited Lahore last week to galvanise the party's supporters, but the provincial authorities created hurdles in his political activities, prompting allegations from both sides.

He is set to visit Karachi next week to whip up support for the planned protest drive. The CM had also staged a sit-in outside the Adiala jail after the authorities barred him from visiting Imran Khan. However, he refrained from participating in subsequent protests to avoid legal troubles.
