- 1.4 Rates are to be quoted clearly in digits as well as in words.
- 1.5 Each document/paper submitted by the bidder shall be signed/stamped by the bidder on the face of the document.
- 1.6 Bids shall be upload on EPADS in accordance with Single stage Two Envelope Procedure.
- 1.7 Bidder shall examine the Bid Evaluation Criteria and insert appropriate document in the Technical / Financial Proposal accordingly.
- 1.8 Conditional Bids, Telegraphic Bids, Bids not accompanied by Bid Security of required amount and form, bids received after specific date and time and bids of Black Listed firms shall be treated as rejected / non-responsive.

#### 2. Eligibility Criteria (Mandatory Requirement)

Eligibility Criteria: The bidder who meets the following eligibility criteria / mandatory requirements would be declared responsive for further evaluation as per the Evaluation Criteria specified in this bidding document. Verifiable documentary proof for all following requirements is a mandatory requirement, noncompliance will lead to disqualification. The bids disqualified / not responsive to the MANDATORY ELIGIBILITY EVALUATION CRITERIA provided shall not be eligible for further evaluation.

#### **Eligibility Criteria:**

Bidder which meets the above **eligibility criteria** / **mandatory requirements** would be declared responsive for further evaluation as per the Evaluation Criteria specified in this bidding document. Verifiable documentary proof for all following requirements is a mandatory requirement, noncompliance will lead to disqualification.

#### 3. Financial Proposal

- 3.1 Bidder(s) must ensure that the following documents are enclosed with the <u>Financial Proposal.</u>
- 3.2 Bid Security of required amount in shape /form of pay order.
- 3.3 Bid form(s)/Price Schedule duly filled in all respect clearly quote the price.
- 3.4 Once again note that bidder must ensure that the Bid Form / Price Schedule is filled in all respect, without any confusion, there should not be any over-writing, double writing, crossed, additional conditions and Rates are quoted clearly in digits as well as in words.
- 3.5 Bidder(s) must understand that all payments / transaction shall be made in Pakistani Rupees (PKR) only.
- 3.6 Bidder(s) must work carefully and gross rates to be quoted, including all applicable taxes and also incorporate the impact of Sales Tax. NICVD shall made payments after deduction of all applicable taxes including Income Tax & SST and other taxes, if any.
- 3.7 Only those who qualified in Mandatory Evaluation shall be eligible for Financial Proposal(s). All bids shall be opened online through EPADS.
- 3.8 Bids not accompanied by the Bid Security of required amount and form shall be rejected.
- 3.9 Procuring Agency shall not be responsible for any erroneous calculation of taxes and all differences arising out shall be fully borne by the Successful Bidder. However, any subsequent changes in rates or structure of applicable taxes by the Government at any time during execution/evaluation period shall be passed to the Procuring Agency.

#### 4. Validity of Bids: -

Bids shall remain valid for ninety (90) days w.e.f, date of opening of Technical Proposals. The bids without or less than Ninety (90) days validity will be rejected.

#### 5. Alternate Bids: -

Alternate Bids shall NOT BE ALLOWED, if any bidder elects to submit alternative bid(s) / proposal(s), both bids ORIGINAL and ALTERATIVE will be rejected straightaway.

#### 6. Announcement of Bid Evaluation Report

- Bids/Offers including Technical Proposal and Financial Proposals to be evaluated by the Committee constituted by the NICVD for the purpose.
- The Bid Evaluation Report shall be announced and shall be hoisted on websites of the Authority (EPADSS PPRA) and Procuring Agency and intimated to all the bidders at least three (3) working days prior to the award of Contract.

#### 7. Award of Contract: -

- 7.1 The bidder whose offered rate is found lowest amongst other technically qualified bidders shall be considered for acceptance of the offer provided that it fulfills the laid down terms and conditions of the tender, irrespective of their score in the previous step.
- 7.2 NICVD reserve rights to cancel any/all bids, subject to the relevant provisions of SPP Rules 2010 (Amended up to date).

#### 8. <u>Signing of Contract</u>: -

8.1 In case of award, the contractor shall sign the contract on appropriate stamp paper. All charges including payment of duty shall be borne by the Contractor.

#### 9. Period of Contract: -

Initially contract shall be signed for a period of One-year (12 months), however, NICVD at its own discretion can extend the period of contract for a further 01 (01) Years till the finalization of new tender. The contractor shall be bound to provide the services for extended period with increase in rate 10% yearly with same terms & conditions.

#### 10. <u>Bid Security / Performance Guarantee</u>: -

The Bidder shall enclose the **Bid Security not less than 1% of the total contract value of the 12 months** (one year) in the shape of Deposit at Call or Pay Order or Demand Draft or a Bank Guarantee in favour of Executive Director, NICVD Karachi issued by a scheduled bank in Pakistan valid for a period of 28 days beyond the bid validity period.

- 10.1 The Bid Security of unsuccessful bidder shall be returned after award of contract or within one week of expiry of bid.
- The Successful bidder shall submit the <u>Performance Security not less than 3% of the total contract value of the 12 months (one year)</u> in the shape of Deposit at Call or Pay Order or Demand Draft in favour of Executive Director, NICVD Karachi issued by a scheduled bank in Pakistan valid for a period of ninety (90) days beyond the date of completion / expiry of the contract.
- 10.3 The Bid Security of successful bidder shall be returned after receipt of Performance Security. However, the successful bidder can adjust the Bid Security towards Performance Guarantee, in this situation; the successful bidder shall submit the balance amount on account of Performance Guarantee.
- The Performance Security shall be forfeited, in case of bidder fails to provide the satisfactory services. The Performance Security of the bidder shall be returned after expiry of contract period.
- 10.5 After finalization of tender procuring agency requires signing of a written contract agreement on stamp paper with 0.35% of total awarded amount as per instruction of Sindh Revenue Board, duly attested by Oath Commissioner from the date on which the signatures of both the procuring agency and the successful bidder are affixed to the written contract. Or/0.35% Stamp duty of the value of the contract amount will be affixed on the bills.

#### 11. <u>Commencement of Services</u>: -

11.1 Services shall be commenced from the date of signing of contract agreement.

#### 12. General Conditions: -

- 12.1 It will be the responsibility of the Bidder that all factors have been investigated and considered while submitting the Bid and no claim whatsoever including those of financial adjustments to the contract / Letter of Acceptance awarded under this Bid Process will be entertained by the NICVD. Neither any time schedule, nor financial adjustments arising thereof shall be permitted on account of failure by the Bidder.
- 12.2 Bidder shall comply with all Pakistani Laws, permits, codes and regulation applicable to the bidder's performance of services. Bids against the Government Rules and Policy, Conditional Bids, Telegraphic Bids, Bids not accompanied by Bid Security of required amount and form, bids received after specific date and time and bids of Black Listed firms will not be considered and will be rejected.
- 12.3 Bidder will follow the disciplinary rules of the NICVD.
- 12.4 The NICVD reserves the right to increase / delete the number of *ITEMS* to be covered on the same rates and terms and condition of the Contract Agreement.
- 12.5 It must be clearly understood that the Terms and Conditions and Specifications are intended to be strictly enforced. No escalation of cost except arising from increase in quantity by the Bidder on the demand and approval of the Competent Authority of NICVD will be permitted throughout the contract period.
- The tenderer should be fully and completely responsible for all the deliveries and deliverables to the NICVD, Karachi. Bidder shall not claim or charge transportation, loading / unloading, labor or any other charges related to or in the name of logistics, accidents, insurance, freight etc.
- 12.7 Bidder shall be responsible for remedying the defect(s) on the same date on which complaint was launched.
- 12.8 Bidders are also required to state, in their proposals, the name, title, contact number (landline, mobile), fax number and e-mail address of the bidder's authorized representative through whom all communications shall be directed until the process has been completed or terminated.
- 12.9 Failure to supply required items / services within the specified schedule will invoke penalty as imposed by the competent authority of NICVD.
- 12.10 NICVD will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
- 12.11 The Bidder will provide the Quarterly Repair and Maintenance Report to the nominated person of NICVD.
- 12.12 Bidder shall not be allowed to alter or modify his bid after the opening of the bids. However, the procuring agency may seek and accept clarification to the bid that do not change substances of the bids.
- 12.13 The Bids shall be evaluated in accordance with the specified evaluation / eligibility / qualification / responsiveness criteria and terms & conditions of the bidding document.
- 12.14 Bidding Documents shall take precedence, in case of discrepancies between the Invitation for Bids

- (IFB) /Notice Inviting Tender (NIT) and the Bidding Documents.
- 12.15 Bidder will depute the supervisors and other adequate staff for carrying out the desired services.
- 12.16 Bidder will be liable for any loss or damage caused by any act or default on the part of his servant or employee to the said premises and / or NICVD property on which decision of NICVD will be final.
- 12.17 During the currency of the contract, the firm will provide goods and services as per terms and conditions, to be settled later on in the shape of contract agreement.

#### 13. Redressal of Grievances by the Procuring Agency: -

13.1 Redressal of Grievances & settlement of dispute will be as per Rule 31 of SPPRA Rule-2010 (Amended upto date).

#### 14. <u>Cancelation of Contract</u>: -

14.1 If the contractor fails to provide the satisfactory services, the NICVD shall be entitled at his option to cancel the contract and recover the damages besides forfeiture of Performance security. The NICVD shall not be liable to any risks and costs whatsoever in consequence of such cancellation of the contract.

#### 15. Arbitration: -

Any difference or dispute or liability of whatsoever nature arising out of the contract or in any way relating to the contract or to its construction or fulfillment should be settled as far as possible, amicably between the NICVD and Contractor. If the parties fail to come to an amicable settlement the same shall be referred to the award of Arbitrators to be nominated one each by the NICVD and Contractor within fifteen (15) days of notice from either side or in the case of the said Arbitrators not agreeing, then to the award of an Umpire to be appointed by the Arbitrators in writing prior to proceeding with the arbitration. The decision of the Arbitrators or the Umpire, as the case may be, shall be final and binding on both the parties. The arbitration shall take place at Karachi, under Pakistani Law of Arbitration.

#### 16. Applicable Laws: -

16.1 The Contract shall be governed by the Laws of Pakistan and the Courts of Karachi – Pakistan shall have exclusive jurisdiction.

"The polio virus is present in the province's environment, putting young children at risk at any time," Inam-ul-Haq said. "Protecting children's health is a shared responsibility. If even one child misses the polio drops, all children are at risk." According to a statement, 11,134 teams have been deployed in both urban and remote areas of the province.

Inam-ul-Haq warned that polio can lead to permanent disability if neglected and urged parents to take their children to the nearest health centre for routine immunisation against other deadly diseases, including measles, tuberculosis and Hepatitis B.
