"We are auditing election commission data. In the latest audit, we reviewed all the Form 47 election results of constituencies. Out of 265 constituencies where elections were held, we found serious problems in 208 Form 47s, such as calculation errors. In 74pc of the forms, officials didn't write their names or the place where elections were held," he said.

He told parliamentarians that election officials unloaded the incorrect documents to their website to show election results, and changed them later.

Meher Bano Oureshi, the daughter of incarcerated former foreign minister Shah Mehmood Qureshi and a candidate in the Feb 8 polls, described the exercise as "unprecedented election with fascist tactics".

She claimed the PTI was "banned, not allowed on
